

# BUSINESS ADMINISTRATION 2.0 - ASSOCIATE IN SCIENCE FOR TRANSFER

The Associate in Science degree for Transfer (AS-T) in Business Administration 2.0 meets the lower division course requirements necessary for the California State University (CSU) system. It is a blend of disciplines, including accounting, business law, business theory, economics, and mathematics. This degree is ideally suited for students wanting to pursue careers in any size of business, whether profit or non-profit. The courses offer a strong foundation for concentrating in business areas such as Accounting, Finance, Human Resources, International Business, Management, Management Information Systems, and Marketing.

## To be awarded the Associate in Science in Business Administration 2.0 for Transfer degree, students must:

(1) Complete 60 semester units or 90 quarter units which are eligible for transfer to the California State University (CSU) system, including both of the following:

(A) The California General Education Transfer Curriculum (Cal-GETC) Requirements.

(B) A minimum of 18 semester units or 27 quarter units in a major or area of emphasis, as determined by the community college district.

(2) Obtain a minimum grade point average of 2.0.

*While a minimum of 2.0 is required for admission, some majors may require a higher GPA. Please consult with a counselor for more information.*

Associate Degrees for Transfer (ADTs) also require that students must earn a "C" or better in all courses required for the major or area of emphasis. A "P" (Pass) grade is an acceptable grade for courses in the major if the course is taken on a "pass/no pass" basis.

Upon successful completion of this program, students will be able to:

- Demonstrate knowledge of fundamental business concepts and principles and how they apply to the strategic interests of business organizations in the competitive environment.
- Collaborate effectively as a member of a diverse team to define a business problem, collect relevant information, identify potential solutions, and select and support an appropriate course of action.
- Prepare and present a cohesive, coherent oral argument, proposal, or illustration that advances the interests of a business organization.
- Develop an awareness of ethical, social justice, and social responsibility issues in the business and economic environment and identify connections between individual and collective rights and responsibilities.
